# [USC02] 26 USC Ch. 24: COLLECTION OF INCOME TAX AT SOURCE ...

Any person violating any of the provisions of the Public Health Act [24-1-1 NMSA 1978] or any order, rule or regulation adopted pursuant to the provisions of the Public Health Act is guilty of a petty misdemeanor and shall be punished by a fine not to exceed one hundred dollars (\$100) or imprisonment in the county jail for a definite term not to exceed six months or both such fine and imprisonment in the discretion of the court.
